Justice Susan Owens

On November 7, 2000, Judge Susan Owens was elected the seventh woman to serve on the Washington State Supreme Court. She joined the Court after serving nineteen years as District Court Judge in Western Clallam County, where she was the County's senior elected official with five terms. She also served as the Quileute Tribe's Chief Judge for five years and Chief Judge of the Lower Elwha S'Klallam Tribe for six plus years.

Justice Owens attended college at Duke University. She attended law school at the University of North Carolina at Chapel Hill, receiving her JD in 1975. She was admitted to the Oregon State Bar in 1975 and the Washington State Bar in 1976.

Justice Owens serves on many committees, including the Administration, Budget, Rules, Traveling Court Committee and serves as a member of the Gender and Justice Commission. She is the Court's chair for the Fall Judicial Conference and is Vice-Chair for the Bench-Bar-Press Committee of Washington. She also serves on the Washington State Bar Association's Leadership Institute Advisory Board.



Judge Rich Melnick

Rich Melnick has served the public for over 30 years as a judge and a prosecutor. Judge Melnick has presented educational programs statewide on various topics including ethics, search and seizure, trial advocacy, evidence, and constitutional law. He is a former Dean of Washington State's Judicial College and previously taught at Clark College.

Judge Melnick did his undergraduate work at Northwestern University and received a B.A. with double majors in history and political science. He received his law degree from the Northwestern School of Law at Lewis and Clark College where he was selected as a member of the Cornelius Honor Society. Judge Melnick remains active in community activities.
